COMMUNICATING WITH KIDS



TRANSPARENCY

Make sure you are transparent with all your communications



GROUP COMMUNICATION

Use group communications in a controlled environment



INCLUDE PARENTS

Communicate through parents for under 12's and copy in parents for over 12's



NO ONE CHILD

NO one to one communication with just one individual child



DE-IDENTIFY

A child's identity must be masked and never shared



MIN OF 2 ADULTS

At least 2 adult leaders or 1 adult leader and the parent/guardian of the child

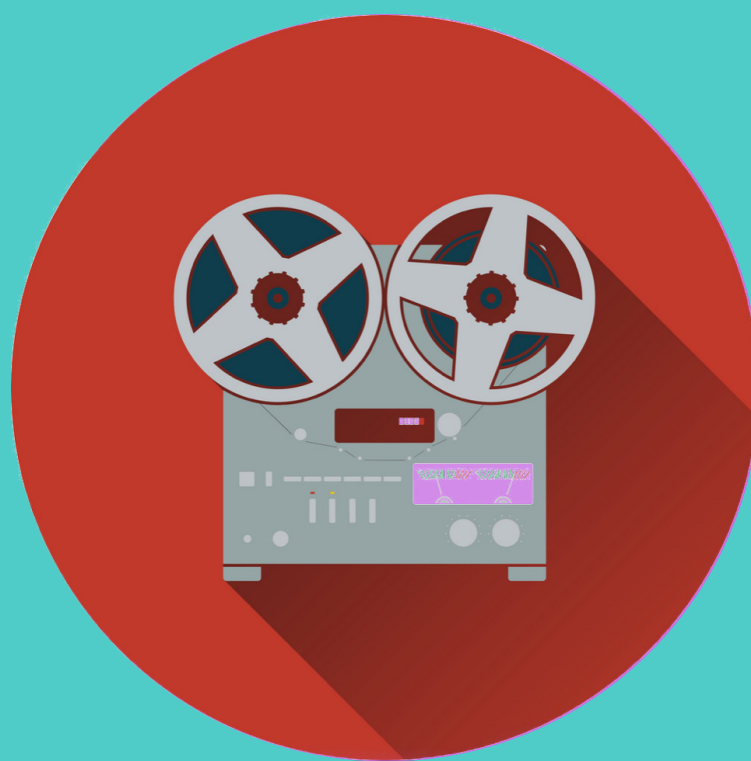

COMMUNICATING WITH KIDS



DEVICE PUBLIC AREA

Child's device should be in public area of the home



RECORDING

Virtual meetings should be recorded - with parental consent



RECORD KEEPING

Record the date and attendance of all leaders and participants



VET PARTICIPANTS

Screen all names, use waiting rooms and lock meeting so no 'surprise' participants



CHILD NEVER ALONE

Never leave a child alone in a virtual meeting without leaders or parents around

- Check if need to register with Local Conference for event under their oversight



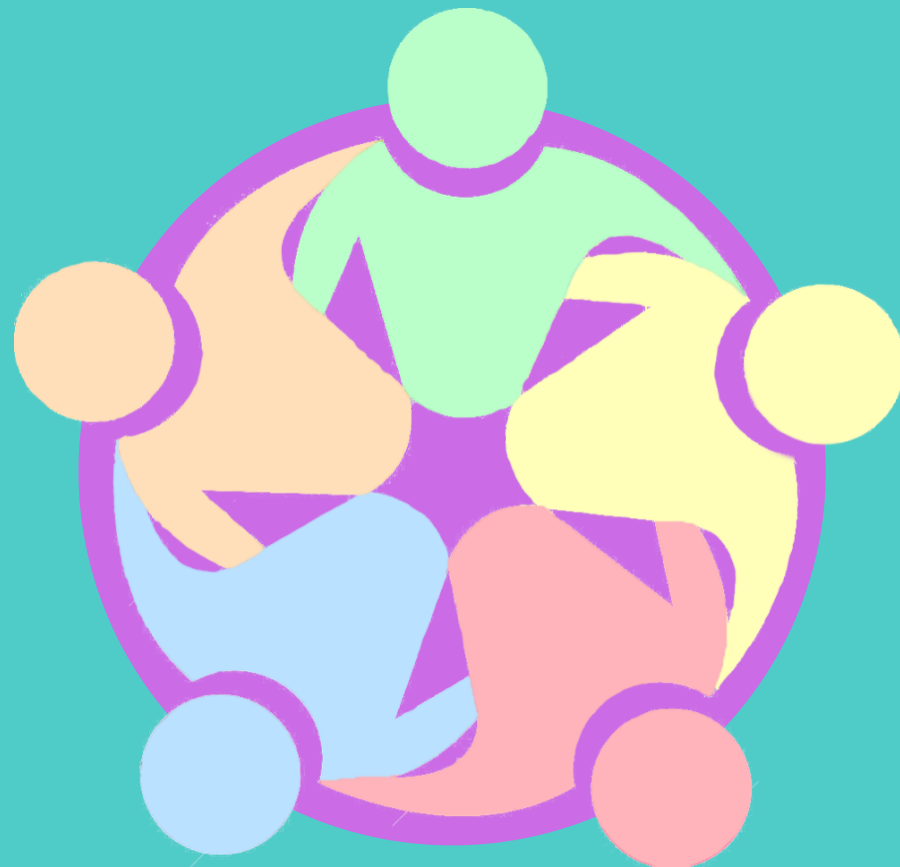
